Meat May Not Be Pre-Cooked. All other ingredients must be chopped or prepared during the preparation period.

NO BEANS OR PASTA ALLOWED!

Beans can be served to the public
only, not to the Judges.

Contestants are responsible for supplying all of their own cooking utensils, etc. Cooking area must be covered.

The sponsors of the cook-off will provide an area for each contestant.

Judges will be told there is one and only one criteria for judging chili: VOTE FOR THE CHILI YOU LIKE BEST!
